1. How long have you lived in Lawrence and what do you do for a living?

I have lived in Lawrence for 20 years. As a disabled veteran of the Iraq War I volunteer at a wide range of organizations across Lawrence and Douglas County such as Independence Inc., CERT, etc.

2. What experience do you have that you believe qualifies you to be a strong city commissioner?

My military experience as a truck commander in Iraq, along with being a supervisor for 5 years at the University of North Dakota, and my time as a team leader and trainer during my work at American Woods, Inc. have allowed me to develop and cultivate the skills to listen effectively, communicate intelligently, and make decisions based on data available in the moment.

3. What do you believe is the City's role in supporting the development of high paying jobs and economic development in general?

City governments work alongside local entities to encourage economic development. Focusing just on high-paying jobs is tunnel vision in action and I work to not engage in such behavior. As the Lawrence economy is diversified for low, middle, and high income jobs this will ensure long term stability for the city's coffers.
